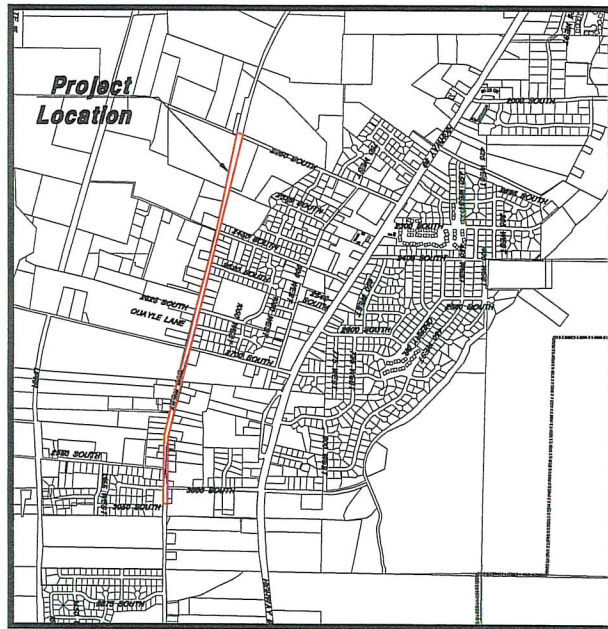

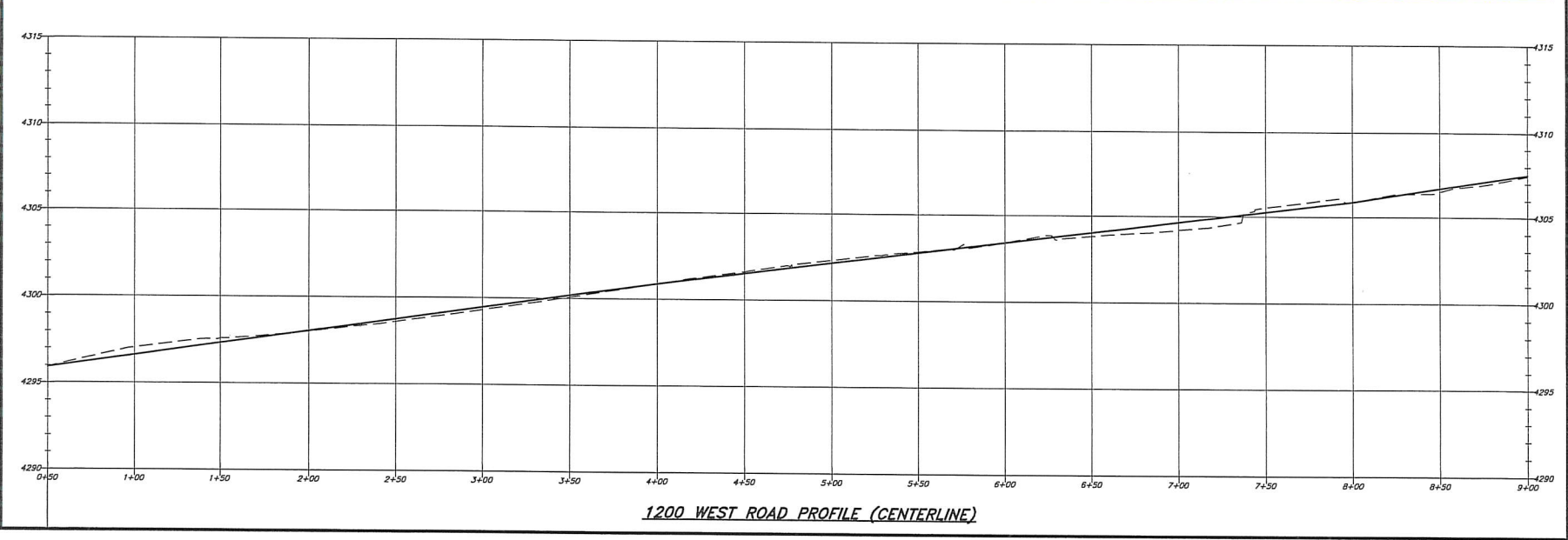
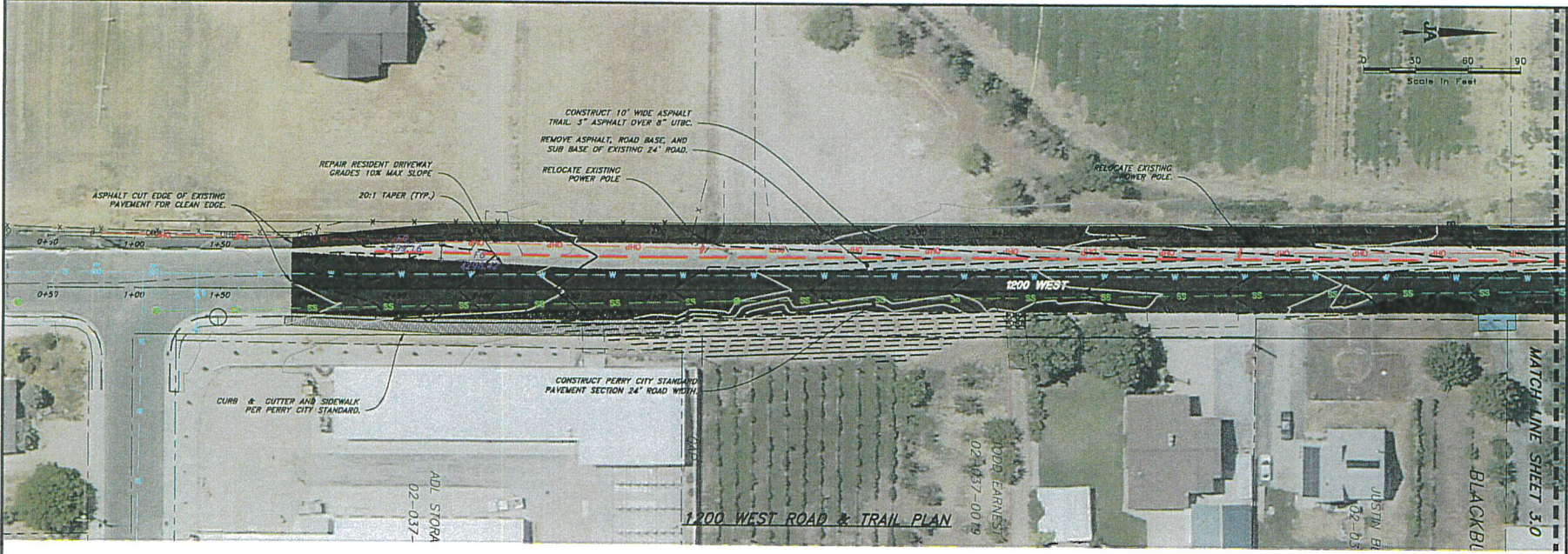


Location Map

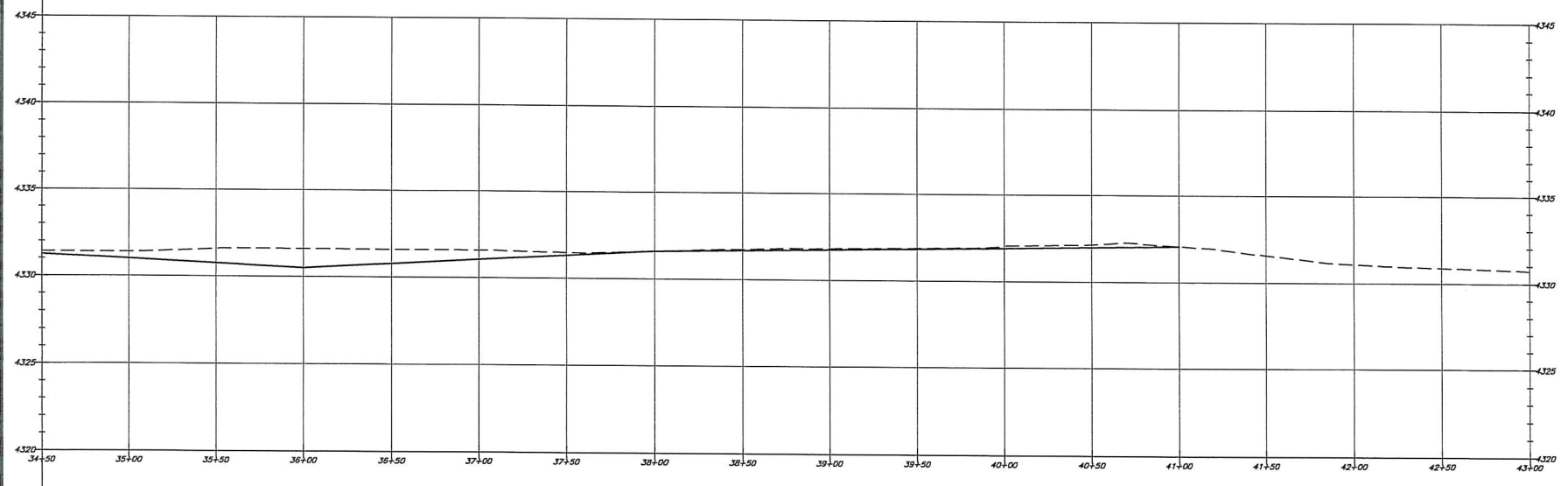
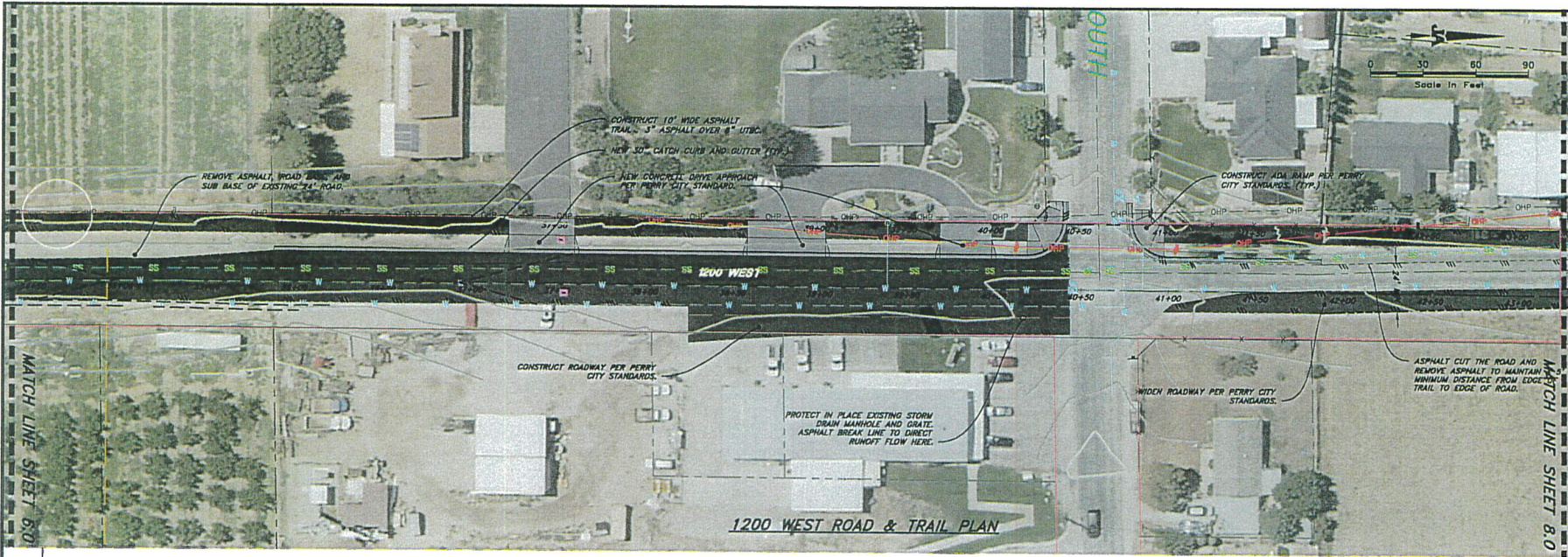
1200 WEST ROAD PROFILE (CENTERLINE)

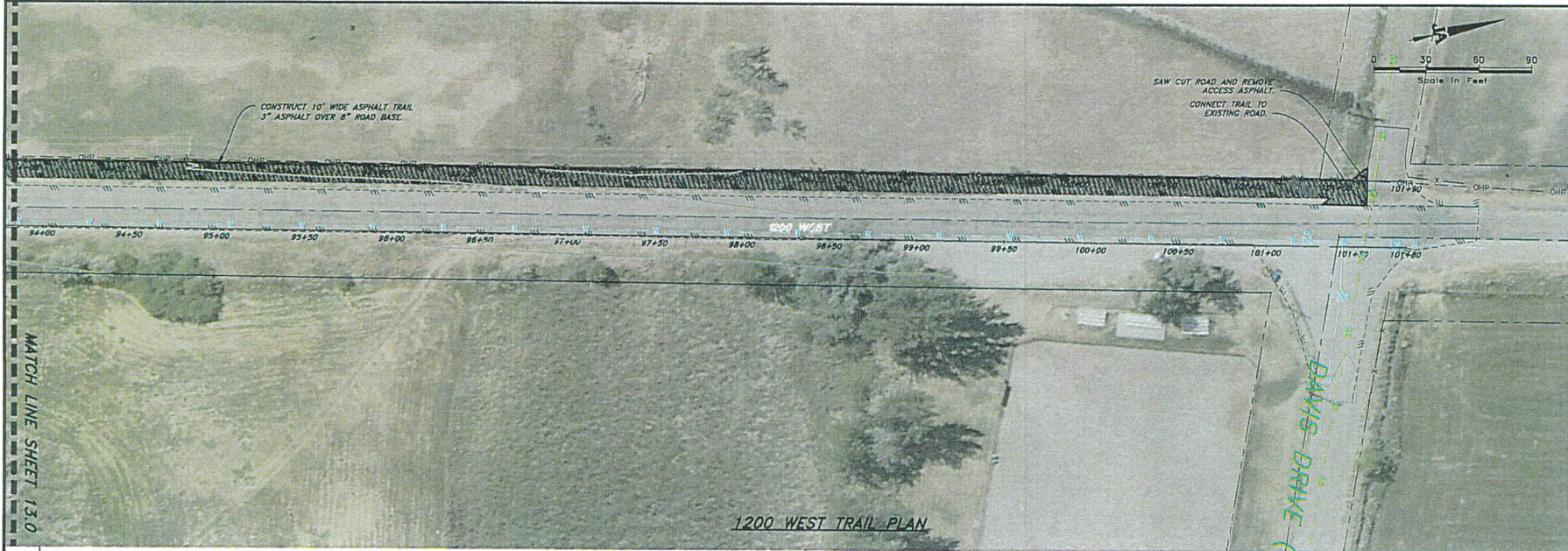


1200 WEST TRAIL PROFILE (BACK OF WALK)

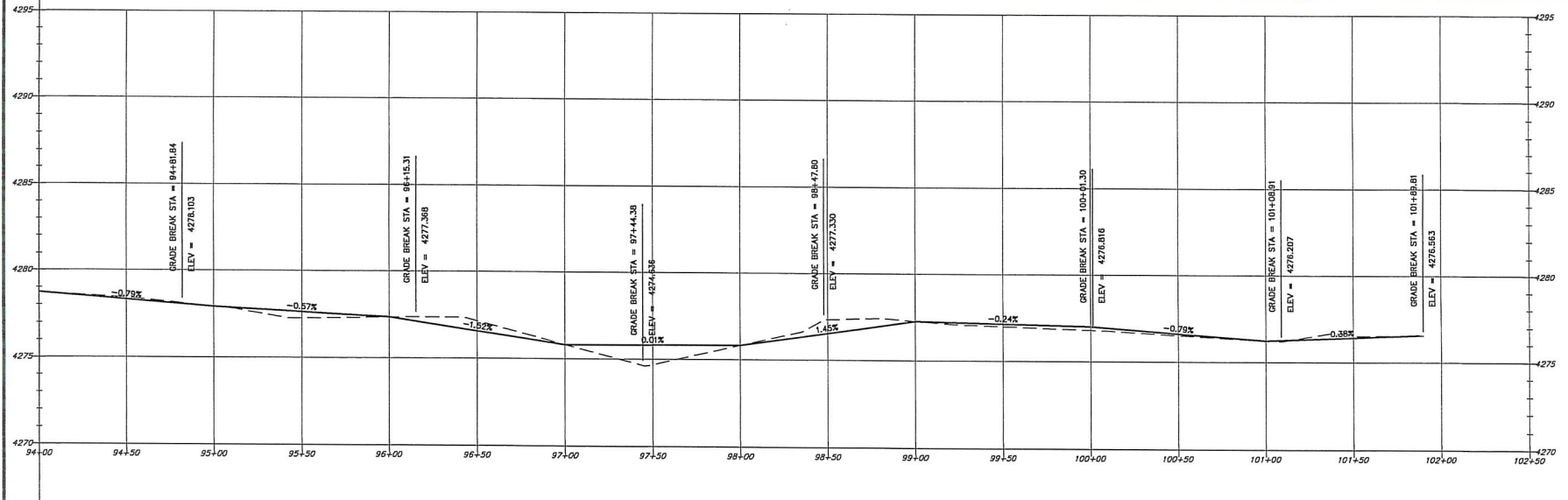
