Why Do We Conduct On Board Surveys?

○ Fulfill Federal Requirements

- Title VI regulations (49 CFR part 21) require that *"passenger surveys shall be employed by transit providers on a schedule determined by the transit provider but no less than every five years."*
 - Previous surveys in 2006, 2011, 2015, 2019

$\,\circ\,$ Develop demographic profiles with trip and fare usage information

- \circ $\,$ Informs agency decision making $\,$
- \circ Origin and Destination (OD) data supports updates to regional travel demand model



2024 OB Survey Administration Details

- Timeframe: February through April 2024
- Conducted by Resource Systems Group, Inc. (RSG). and ETC Consultants
 - Consultants for 2015 and 2019 UTA OBS
- Surveys were conducted on Bus, Rail, and On Demand using digital tablets with real time geocoding

Survey Target and Actual Samples

Origin-Destination Survey (OD)

- Tablet-based survey provides information on demographic profiles and travel patterns
- Target sample: 9% weekday bus and rail, 1.5% weekend bus and rail, and 50 On Demand
- Actual sample: 10% weekday bus and rail, 2% weekend bus and rail, 74 On Demand

TOTAL: 13,795 responses

7,347 bus; 4,486 TRAX; 1,770 FrontRunner; 118 S-Line; and 74 On Demand

\circ On to Off Survey (O2O)

Target Sample: 20% of ridership for rail, and 20% bus routes surveying more than 2,800 riders

TOTAL: 22,353 on-to-off pairs were collected

6,440 (31%) bus and 15,913 (30%) TRAX



GENDER

- 41% Female, 58% Male, 1% Other.
 - Consistent with 2019 OBS.

AGE

- Over 1/2 of riders are 34 and under (62%)
 - Consistent with 2019 OBS.

INCOME

• 54% of our riders earn less than \$45,000 per year.

RACE

• Riders who identify as White/Caucasian had the highest response rate (64%), which decreased by 12% from 2019.

Vehicles Per Household

• Since 2019, there has been an increase in zero vehicle households across bus and rail.

OnDemand	33%	N/A	



FREQUENCY OF USE

• Riders using the system five or more days a week (58%) decreased by 6%.

TRANSFERS

- Rider trips with 0 transfers increased by 5%.
 - Transit-Reliant riders are more likely than choice riders to have more than one transfer on their trip



FARE PAYMENT

- 35% selected electronic card as their method of fare payment.
 - \odot 3% decrease from 2019
- 15% indicated use of cash for fare payment on bus.
 - \circ 7% increase from 2019

ACCESS AND EGRESS MODES

• Most respondents access and exit transit by walking.

On Demand Highlights

2024 is the first year On Demand was included in the On Board Survey

 \circ In 2024, 74 origin-destination surveys were collected on UTA's On Demand service

Innovative Mobility Zones surveyed:

- □ South Davis
- □ Salt Lake City West Side
- □ South Sale Lake County
- 🗆 Tooele

Of all the modes, On Demand has the greatest reporting of transit-reliant riders

 \odot 76% of On Demand riders are transit-reliant

On all other modes, more than 50% of riders possessed a driver's license

 \odot 78% of On Demand riders do not have a driver's license
