# **Complimentary Fare Update**



## **Resolution R2021-07-04**

- In July 2021, the Board approved a resolution authorizing the authority to enter into certain sponsored fare agreements for special events as part of the authority's COVID recovery efforts.
- Three (3) Event Partnerships gave 58,000 individuals access to transit:
  - April 2-3: The Church of Jesus Christ of Latter-day Saints General Conference
  - April 23: Salt Lake Marathon
  - May 20-22: Tumbleweeds Film Festival
- Estimated that 4-8% of attendees utilized their transit benefit, for total ridership of 4,600 to 9,300



## Background

#### **Ogden Onboard**

- Initiated in 2018, design firm Moore, lacofano, and Goltsman
- Part of the Ogden Bus Rapid Transit (BRT) Corridor Analysis
- Ogden Station included in corridor analysis as one of four development nodes


#### Make Ogden

- Initiated in 2019, Design Workshop
- Establishes a comprehensive vision for Downtown Ogden





## **Purpose of the Amendment**



#### **Premises**

- Reconciles recommendations made in Ogden Onboard and Make Ogden
- Identifies major infrastructural improvements
- Provides more detailed vision for the FrontRunner station
- Provides implementation plan, including phasing schedule, stakeholder responsibilities, funding sources, etc.



## **Overall Vision**

#### **Union Station Campus**

- Preserved / renovated Union Station building
- Gateway to 25<sup>th</sup> Street

#### Transit Plaza

- Reconfigured bus loop / BRT platform
- High-intensity land uses

#### **Innovation District**

 Dense mixture of residential, office, and maker space

#### Residential

 Residential to support neighborhood activity





## **Circulation Plan**

#### **Street Connections**


- Traffic calming along Wall Street
- Framing of smaller, walkable blocks within development
- Additional west-bound connections

#### **Active Transportation**

- Strong pedestrian crossings along Wall St.
- Pedestrian connections within overall neighborhood & individual blocks

## **Parking & Transit Plan**

#### Park & Ride Facilities


- 400 dedicated transit stalls in southern parking structure with expansion option





#### **Public Engagement Overview**

Component	Dates	Additional Detail			
Public Notice	March 2	A public notice was published across major news publications in areas with proposed major changes and on the Utah Public Notice Website.			
Public comment period	March 2 – April 1	30-day period was required. Public notice was published. Comment was accepted via email, mail, online form, phone, and in-person at Customer Service locations.			
Public hearing (Virtual)	March 17	15 days after public comment period announced, this public hearing was held virtually over Zoom. UTA staff presented information about proposed changes and answered questions. Registered participants were invited to provide public comment during the meeting. A recording was made available following the event.			
Customer Service	March 2 – April 1	Customer service offices across the service area (3 locations) supported information sharing about proposed changes for members of the public to learn more and provide comment.			
Virtual engagement	March 2 – April 1	Available throughout the comment period online, included virtually accessible information and feedback opportunities through OpenUTA. (Rideuta.com/August)			
Communications	March 2 – April 1	Utilized key communication channels to share information about Change Day process, including website and social media.


SLC Westside August 2022




UVX: 6-minute service on main line
